

**Minutes of the DDC meeting for the month of September/2022 in respect of
Charaideo District held on 30-09-2022 at 11.00 AM in the Conference Hall of DC
office, Charaideo**

Members present: As per ANNEXURE-I

The meeting was presided over by Sri Paul Barua, ACS, Deputy Commissioner, Charaideo. The Chairman welcomed Sri Jogen Mohan, Hon'ble Minister of Revenue & Disaster Management, Hills Area Development and Hon'ble MLA of 105-Mahmora LAC, Sri Dharmeswar Konwar, Hon'ble MLA of 106-Sonari LAC and all the members present in the meeting. The meeting was initiated with the discussion on the action points of the following development departments.


1. **P & R D:** The CEO, Charaideo Zila Parishad stated that the Physical work of Amrit Sarovar is yet to be started. He informed that a land issue has been raised in the Sapekhati Reserved Forest Area. The DC directed to DFO(T) to do the needful for clearance, so that the P & R D Department may start the physical work of Amrit Sarovar scheme immediately. Viewing the direction and urgency of Central and State Government, the Hon'ble MLA Sonari LAC stated that the departments should start all sanctioned works without waiting for foundation laying by Hon'ble Ministers and MLA's. The Deputy Commissioner directed the CEO, Charaideo Zila Parishad to start the construction work of pond immediately after Durga Puja Vacation. The CEO, Charaideo Zila Parishad informed the meeting that the inactive Job-cards have been included for Aadhaar seeding, for which to meet the target for Aadhaar seeding with job cards become difficult. The DC instructed the CEO, Charaideo Zila Parishad to expedite the Aadhaar seeding process.
2. **PWD (Bldg.):** The Ex. Eng. PWD (bldg.) informed that cumulative physical progress of medical college is 30%. He appraised that formal notice has been issued to the contractor for the slow progress of Archery Academy Kanubari. The DC viewed serious concern upon the slow progress of DTO office building and directed the Ex. Eng. to take necessary action for speedy implementation of the project.
3. **Education:** The Inspector of Schools, Charaideo, informed that 126 new teachers have been appointed in High Schools and Higher Secondary schools of the district. He stated that 183 more vacant posts of teacher are yet to be filled up. The DC suggested that the amalgamation process of schools should be done in discussion with all stakeholders. The Deputy Commissioner suggested to take initiative to fill up all the vacant posts of teachers immediately and take necessary steps for quality education in schools.
4. **Health:** The meeting was discussed on the COVID-19 vaccination, Mother & Child Health, Institutional Delivery, MMR & IMR, CM free diagnostic service, PM free dialysis programme, Atal Amrit Abhiyan, Ayushman Bharat, NELP, NVBDCP, NT,EP etc. The Jt. Director, Health Services informed that the 2nd dose of vaccination of COVID-19 above 18-year is 81.16%. The DC directed to the Joint Director of Health Services to focus and improve the achievement on the Central Govt. schemes operating under Health Department.
5. **Agriculture:** The DAO informed that 96.52% of Aadhar Seeding under PM-Kishan has been achieved. He stated that land data Updation progress is 90%. Relating to the eKYC under PM-Krishan, 83% has been achieved so far. He also stated that 4 (four) new FPC formation has been received in the district.
6. **Food & Civil Supply:** The Asstt. Director, Food & Civil Supplies, Charaideo informed the meeting that approximately 97,000 Ration card holders may be deprived from getting the benefit of ration card due to the unavailability of Aadhaar card in the district. The DC viewed serious concern on it and directed to link the Aadhaar with ration card within three months .
7. **Transport:** The DTO stated that out of the target of ₹ 9.52 crore, Rs. 3.8387621 crore revenue has been collected in the district during the year 2022-23. The DC directed to DTO, Charaideo to make frequent operation against drunk drivers. He also directed to take necessary action for wearing of Uniforms by Bus drivers, Conductors and Handymen in consultation with bus owner associations.
8. **PWD (NH):** The Ex. Eng. PWD (NH) Jorhat stated that the Ph-1 compensation of land acquisition will be released shortly related to the 28 KM NH highway connecting Sivasagar to NH 702 of Charaideo district.
9. **Forest:** The DFO (T) informed to the meeting that as per direction of the DC in DDC meeting for the month of August, public awareness programme on afforestation has been organised in Borhat range, Sonari range, Chola RF and among the students in college and schools in the district. He also appraised that Rs. 44,45,926.00 revenue has been collected so far by the department.
10. **Irrigation:** As per report of Irrigation deptt., two schemes were sanctioned under RIDF-XXVI (NABARD) which were distributed one in Mahmora Dev. Block and one in Lakuwa Dev. Block. The boring of both the schemes has been completed. Now, Progress of construction of

pump house in Mahmora is 35% and Lakuwa is 45%. He also informed that currently 23 schemes have been operating in the district, which has covered 1170 hector area of agriculture land.

11. **Water Resources:** As per report of Water Resource deptt. , out of nine sanctioned schemes under SDRF, two schemes have been completed and the remaining works currently been halted. Since, the rainy season is over, the works would be started soon. The DC directed the Ex. Eng., Water Resource to be prepared in all respect so that the works could be completed within the stipulated time fixed by Govt.
12. **Soil Conservation:** As per report of Soil conservation, Jorhat that out of three projects taken up under RIDF-XXV during the year 2020-21, work of one project has been completed. It was also intimated that under RIDF-XXVIII - 2022-23, two project proposals with an estimated cost of ₹ 80.16 lakh have been taken up.
13. **Sericulture:** The meeting discussed the sericulture schemes taken up under world bank finance, APART programme 2019-2020, 2020-21 & RKVY 2018-19. This relates to Eri house, Plantation of Som/Kesseru. The DC directed to expedite the schemes to meet the target on stipulated time.
14. **Handlooms & Textile:** The Supdt. of Handloom & Textile stated that under Weavers' MUDRA loan programme for the year 2022-23, application has been collecting to fulfil the target of 50 beneficiaries. He apprised the meeting that under SAMARTH scheme weaver registration process is going on. As of now, 90 weavers have been registered. In respect of State Govt. scheme Swanirbhar Naari, 5528 women have been registered for the year 2022-23.
15. **Veterinary:** As per report of Veterenary department, National Animal Disease Control Programme (NADCP), Brucellosis vaccinations drive have been conducted in the district. Out of 3280 doses of Brucellosis vaccinations received and out of which 3133 vaccinations have been done.
16. **PHE :** The stated that the achievement of PHE department in respect of JJM during the month of September/2022 is satisfactory. He directed the department to gear up the progress of JJM so that it may come up in the upper rank in CM's dashboard.

At the end of the meeting, Sri Jogen Mohan, Hon'ble Minister of Revenue & Disaster Management, Hills Area Development, Govt. of Assam, suggested to all the HODs that as the Govt. stressed upon expeditious and smooth door step delivery to the user groups, some relaxation may be made while releasing the fund under various schemes within the purview of the Govt. guidelines. He also appraised that the implementing departments/ Committees should take special care for submission of UCs, Photographs and physical progress report of the schemes immediately to DC and Concerned Heads for onward submission to Govt. and for uploading in prescribed portal which in turn will also reflect in CM's Dashboard . He stated that delay in implementation of scheme and freezing the govt sanctioned fund is nothing but a hindrance in the development process of the state. So, he urged upon the implementing departments/agencies to complete all the ongoing schemes and submit UC's urgently so that it could be handover to the user groups and submit full UC to govt. urgently for sanctioning fund for next year. The Minister emphasised that the BDO should take initiative and they should instruct the A/E & J/E concerned to prepare Plan & Estimate of different schemes taken up under MGNREGA, MLAADS, Untied Fund, Assam Darshan, MPLADS etc. so that, more schemes could be implemented in the district. He also instructed all officers to visit the scheme sites for inspection frequently and exchanges their views with the public of the concerned villages regarding the scheme and other any new schemes of the department for their active participation . If any minor issue has been noticed during the inspection then the needful action for rectification may be done prior to inauguration of the scheme. He also instructed to the concerned deptt. to solve the land issue during the construction of Central Warehouse Centre in the district. While discussing about Amrit Sarovar schemes, he mentioned that it is a flagship programme of the Central Govt. Hence, for the effective, efficient and successful implementation of the scheme, he requested all the concerned deptt. to work cohesively and put their effort therein.

The meeting ended with a vote of thanks from the Chair.
