

Minutes of the DDC meeting for the month of December/2022 in respect of Charaideo District held on 28-12-2022 at 11.00 AM in the Conference Hall of DC office, Charaideo

Members present: As per ANNEXURE-I

The meeting was presided over by Sri Paul Barua, ACS, Deputy Commissioner, Charaideo. The Chairman welcomed all the members present in the meeting. The meeting was initiated with the discussion on the action points of the following development departments.

- 1. PWD (R):** The Ex. Eng. PWD(R) informed that proposal of compensation for land acquisition under Assam Mala Project amounting to Rs. 66.00 crore is ready and would be submitted to the Government immediately. Out of the total road of 39.60 KM under Assam Mala, bituminous work for 25 KM road has been completed. The meeting discussed about ongoing projects of PMGSY, SOPD(ODS), SOPD(G), RIDF, Signature Project, Assam Darshan, CM's Special Package, APART etc. The Chairman asked the Ex. Eng. to expedite all schemes, so that the maximum possible number of schemes would be completed within the dry season.
- 2. PWD (NH):** The Ex. Engineer informed that Rs. 9.00 Crore has been received for Jirat. The Chairman directed to collect the bank account of the land holder, so that the Jirat could be sent directly through bank transfer to the accounts of the concerned affected pattadars. Further, he suggested to hold a separate meeting with the Addl. Deputy Commissioner (Revenue) in this regard.
- 3. Water Resources:** The Ex. Eng. stated that out of nine sanctioned schemes under SDRF, three schemes have been completed and the works of remaining six schemes are ongoing. Further, he mentioned that notice has been issued to the contractors to complete the ongoing schemes by January, 2023. The DC asked the Deptt. to take necessary action for starting new works through tendering process and to complete all the ongoing schemes physically and financially in stipulated time fixed by Govt.
- 4. Social Welfare:** During discussion of the progress of ICDS project, water connection under JJM in AWC, Electricity connection in AWC, POSHAN, PMMVY, UDID schemes of Divangyan etc. The DSWO, Charaideo informed that seven disability identification camps have been done during the month. She further informed that the APDCL authority has issued a huge amount of electricity bill to the Anganwadi Centres in which electric connection is yet to be installed. In this regard, the DC asked the DSWO to write a letter to the APDCL authority to inquire in to the matter and settle it immediately so that no bill may be paid without any use of electricity.
- 5. Irrigation:** The EE, Irrigation informed that out of 19 Irrigation schemes of the district, 15 schemes have been completed and works of 4 schemes are going on. He stated that under PMKSY (phase III), sanction of 2 schemes for small & marginal tea growers have been received. Further, sanction of two schemes under RIDF-XXVIII and four schemes under ADB also received from govt.
- 6. Environment & Forest:** The DC stressed upon the man-animal conflict in the district. He asked the DFO to take necessary steps from the deptt. to prevent the conflict. Regarding various complain for not giving compensation to the victim families caused by wild animal attack, the DC directed the DFO to settle the cases in organising public meetings in the concerned areas and ensure about the compensation given by forest deptt. to the victim families by verifying the bank transaction statement of the concerned family/family members at site so that no one can raise any objection in this regard in future.
- 7. Soil Conservation:** The representative of Soil Conservation stated that five new schemes have been received under SOPD, RIDF and Central Sponsored scheme for the year 2022-23. He also stated that DPR has been prepared in respect of two projects sanctioned under PMKSY 2.0 for the year 2022-23. The three schemes which were sanctioned for the year 2020-21 have been completed in all respect.
- 8. Industry and Commerce:** The AD DICC (i/c) stated that under PMEGP, 69 applications were sponsored to different bank branches. Out of the sponsored applications, 9 applications have been sanctioned and disbursement also made to the three beneficiaries. The Deputy Commissioner asked the department to submit list of application which were pending in different bank branches so that necessary instruction may be given to the concerned banks for sanction of applications and timely disbursement of loan to the beneficiaries.
- 9. P& RD :** While discussing the various schemes under P& RD, the DC asked the CEO to submit details of the quantity of soil remitted and revenue collection from the transferred soil of

the ponds under Amrit Sarovar schemes which are completed more than 50% works. The DC also emphasized on the schemes taken up in the tea garden area by the Development Blocks under MGNREGA and directed all the BDO's to implement the schemes immediately so that schemes could be completed within the winter season.

10. Transport: The DTO stated that Rs. 6.2700324 Crore revenue has been collected out of targeted 9.52 crore in the district during the year 2022-23. He also addressed the meeting about the Vehicle Scrapage Policy, 2022 and requested all HODs to submit the list of vehicles above 15 years of age or the vehicles which are unfit for use even though the age of vehicle is less than 15 years . The DC asked the Addl. Supdt. of Police and other HOD's of Charaideo district to submit the vehicle list above 15 years of age to the DTO .

11. PHED: The Ex. Eng., PHED informed that 7 contractors have stopped the work due to non-received of fund from the Govt. Further, He informed the meeting that ten contractors have not received the schematic ID yet. Therefore, the Pipes, Tapes etc. has not supplied by the supplier. While reviewing the progress of JJM schemes, the Chairman expressed dissatisfaction on the physical progress of departmental work. He directed the Ex. Eng. PHE to sort out the issues related to power connection, portal management etc. and gear up the progress of schemes so that the target could be achieved in an efficient manner within the stipulated time.

12. DDMA: The meeting was discussed about the damages caused by the Strom and hailstorm in the district. In this regard, the Deputy Commissioner, Charaideo informed that assessment of the affected areas has been going on and victimised families have been provided Tripal and other necessary requirements . After completion of assessment, the same would be submitted to the Govt. for sanction of fund for the purpose.

13. Agriculture: During the discussion of Paddy Procurement, the DAO informed that 278 new farmers have been registered so far and 160 MT paddy has been collected till date. He further informed that the deptt. has targeted to achieve 1000 MT Paddy within 15th January, 2023. He mentioned that as per the rule of Govt., two FPC should be available in each block, but only four functional FPC was available in the district. The meeting reviewed the progress of PMKSY, PMFBY, CMSGUY, NFSM, BGREI, RKVY etc. and asked the DAO for proper implementation of the schemes.

14. Fishery: The meeting reviewed the progress of the scheme RIDF-XXIII - "Ghare Ghare Pukhuri Ghare Ghare Maach" (2018-19), RKVY-RAFTAAR (2019-20), PMMSY (2020-21& 2021-22) etc. and asked the DFDO to complete the schemes expeditiously. The Fishery Development Officer inform that the production and income generation from the fishery sector under various schemes in the district from the year 2016 to 2022 are as follows:

15. Health: The SDMO, Sonari informed that mock drills in respect of COVID pandemic have been going on and 42 mock drills have been done so far. For availability of sufficient oxygen cylinder in the district , order has already been placed. The meeting reviewed the progress of various departmental schemes viz. Mother & Child Health, Institutional Delivery, MMR & IMR, CM free diagnostic service, PM free dialysis programme, Atal Amrit Abhiyan, Ayushman Bharat, NELP, NVBDCP, NTEP etc.

16. PWD (Bldg.): The Ex. Eng. PWD (Bldg.) informed that construction work of twenty BOPs in the bordering Abhoypur Reserved Forest area is yet to be started due to non finalisation of land. For expedite execution of the BOP's , the Deputy Commissioner, asked the Ex. Eng., PWD (Bldg.), Addl. Supdt. of Police & DFO to conduct a joint survey to identify the location and all necessary clearance should be done from all concerned so that works of BOP may be started immediately without further delay. He further directed the Police deptt. to monitor and make strict vigil during the construction of BOPs so that the construction work would not be hampered by any miscreant. Further, he instructed the Ex. Eng. to sort out the land issues for construction of model tea garden high school in Borahi T.E. in consulting with the garden management. The meeting also reviewed on the progress of various departmental schemes

implemented by PWD(B) and asked to gear up the progress so that the schemes could be completed within the winter season.

17. Handloom & textile: The Supdt. of Handloom & Textile stated that under APART programme for the year 2021-22, 100% Physical achievement has been completed. He apprised the meeting that under SAMARTH scheme, 140 weavers have been registered so far and MIS is going on. He informed that under Weavers' MUDRA Loan, out of 50 weavers, 41 applications have been submitted to various bank during the month of December, 2022. He also informed the meeting that under the state Govt. scheme "Swanirbhar Naari", 5528 beneficiaries have been enrolled and two procurement centres would be open in January, 2023 for procurement of Gamusa.

18. Municipality: The Ex Officer, Sonari MB stated that door to door garbage collection has been going on. He stated that segregation of waste materials at site would be started from January, 2023 in Sonari Municipal area. He further stated that necessary drives for awareness of public on segregation of garbage in the household level would be started soon.


19. Library: The meeting was discussed on the various activities of the library deptt. During the discussion, the sub divisional librarian emphasized on repairing of library building and purchasing of books. In this regard, the Chairman suggested to communicate with the higher authority for sanction of funds.

20. Economics & Statistics: The SDSO, Charaideo, stated that the National Sample Survey (NSS) and other survey is regularly going on in the district. However, the agricultural census has not started yet in the district.

21. Sports: The DSO, Charaideo stated that under CMSGUY, 3rd instalment fund for two playgrounds have been sanctioned in the district. She stated that "Khelo India Small centre" in the district has been registered but no financial sanction is received from the department as yet. Further, she emphasized on the district level competition on various sport and the selected players who would be participated in the state level competition.


22. Co-operative Society: The ARCS stated that 14 societies have been registered in the district. Out of which, election has been held in 11 societies.

In conclusion, the Deputy Commissioner requested all implementing departments to complete the ongoing schemes as early as possible within the dry season. The DC also asked all the BDO's to submit Full UC and Completion Certificates along with Geo Tag Photograph etc. in respect of MLAADS, Assam Darshan, Untied Fund, MPLADS etc. for which entire sanctioned amounts have been released from district authority. The documents are required urgently for uploading in eRupantor portal which would be reflected in the CM's dashboard. Further, the DC requested all HOD's to get ready for observing "District Day" on 16th of February/2023. He stated that though the fund for observing the "District Day" is not received from govt. as yet, showcase of departmental activities, innovative works, Cycle rally, cultural rally may be arranged without any financial involvement. The meeting ended with a vote of thanks from the Chair.
