

Minutes of the Review meeting of Charaideo District held on 16-10-2021 at 1.00 PM in the Chowdang Fishery Park, Khumtai, Charaideo.

Members present: As per ANNEXURE- I

The meeting was presided over by Hon'ble Guardian Minister, Charaideo district Sri Bimal Borah. The Deputy Commissioner welcomed the Hon'ble Minister Revenue & DM, Hills Area Dev., Mines & Minerals & MLA, Mahmora LAC, other dignitaries & the members of different departments and public who attended in the meeting. Initiating the discussion, she spoke in brief about the agenda of the meeting. She informed that district administration had started an initiative to hold review meetings on the progress of various deptts involving the stakeholders so that transparency and awareness of the Govt. schemes are created among them. For initial meeting, the schemes/programmes of following Deptts. were discussed and reviewed in detail.

1. **P & RD:** The CEO, Zilla Parishad gave a detailed overview about various schemes implemented by P&RD Deptt. He also informed the targets and achievements of the PMAY, MGNREGS implemented in Sapekhati, Lakwa, Sonari and Mahmora Development Blocks. He explained the theme of the schemes of "Mohila Sabalakaran and Swa Nirbharshil Nari" etc. among the public to uplift the women empowerment.
2. **DAO:** The DAO informed that under RKVY 2018-19, 45 (Forty five) Power tillers had been distributed amongst the farmers and collection of application from intending farmers also going on. The distribution will continue till the target set for the district is fulfilled. Out of 7 (Seven) Power Paddy Thresher allotted to the district, 5 (Five) Power paddy Thresher had already been distributed and application for remaining 2 (Two) Paddy Thresher have been received. Similarly out of 5 (Five) PTO Operated Paddy Thresher, 2 (Two) PTO Operated Paddy Threshers had already been distributed and applications for remaining 3 (Three) Paddy Threshers have been collected. The DAO stated that under RIDF 2016-17, 139 STW (Diesel), 72 STW (SPV water Pumping System) have been distributed among farmers. He informed the public about the schemes of BGREI 2018-19, RKVY 2020-21, NFSM for the year 2018-19, 2020-21, CMSGUY, NFSM 2017-18 to 2020-21, HMNEH 2020-21. The meeting also discussed about the distribution of Manual Sprayer, Micro irrigation, KCC loans for farmers, Pulveriser & Foot Sprayer. He also informed that they have also taken up Paddy cum Fishery scheme in Charimothia gaon, Atal pathar, Raidongia Na- Kachari areas. The

results were encouraging and they are hopeful of yielding better results in coming financial year.

3. Veterinary: The DVO stated that more than 3000 animals & poultry have been vaccinated. 15370 nos. of animal & poultry have been treated. He also informed the public about the training "MAITRI" scheme under Rashtriya Gokul Mission.

4. Fishery: DFDO gave a brief presentation on the existing schemes being implemented by them in the district. 10 (Ten) nos of paddy cum Fish Culture have been started with the convergence of Agriculture and Irrigation Deptt. The DFDO informed that NABARD has launched a new project viz. Rural Infrastructure Assistance to State (RIAS) to provide financial assistance for creating rural livelihood Infrastructure between NABARD & State on 95:5 basis. Under this scheme, tanks will be constructed on Khas land or suitable area with minimum 1 hector pond. Accordingly, Circle officers have been requested to identify land for this purpose. Hon'ble Guardian Minister directed DFDO to take initiative to implement the scheme involving local unemployed youth.

5. PWD (Roads): The EE, PWD (R) stated that 16 new schemes have been approved under PMGSY. He mentioned that out of 289.35 KM roads and 17 bridges taken up under PMGSY, 272.66 KM roads & 11 bridges have been completed. The meeting was discussed about the SOPD(G), SOPD(ODS), CM's special Package, Signature Project, Assam Darshan etc. While discussing the schemes, the EE, PWD(R) mentioned that the construction of road from Moran to Khotkhoti via OIL has been started. Referring to the discussion held earlier with representatives of OIL, PWD Deptt & District Administration Charaideo. Hon'ble Guardian Minister asked all concerned to take necessary steps for immediate completion of the road from Moran tiniali via Moran OIL Township to Khotkhoti. Further, Hon'ble Guardian Minister directed Deputy Commissioner to complete all formalities of signing MOU with OIL authorities so that work can start within seven (7) days.

6. Irrigation: The Hon'ble Guardian Minister directed EE to complete the installation of solar pump to enhance the income of farmers under "Integrated Paddy cum Pisciculture". For this purpose, the Chairman directed the Irrigation, Fishery and Agriculture Depttto take upconvergence schemes for successful implementation.

7. PHE: Speaking on implementation of Jal Jeevan Mission scheme in the district, Hon'ble Guardian Minister directed to expedite construction of new schemes so that every household should be provided Functional Household Tap Connection (FHTC) by the year 2024. Further Hon'ble Guardian Minister asked the Panchayat representatives to create awareness about the responsibilities of user committees.

Taking part in the discussion, Hon'ble Minister Revenue & DM, Hills Area Dev., Mines & Minerals & MLA, Mahmora LAC, thanked the initiative of Hon'ble Guardian Minister of holding such review meetings which will contribute in implementing various Govt. Schemes in right spirit involving the public.

Concluding the discussion, Hon'ble Guardian Minister asked all present to effectively implement schemes within prescribed timeline so that the district can progress and also to hold meetings outside District Headquarter.

The meeting ended with a vote of thanks from the chair.
