

**Minutes of the DDC meeting of Charaideo District held on 22-09-2021  
at 11.00 AM in the conference Hall of D.C's Office, Charaideo.**

Members present: As per ANNEXURE- I

The meeting was presided over by Smti Binita Pegu, IAS, Deputy Commissioner, Charaideo. The D.C. welcomed all the members present in the meeting. The meeting was initiated with the discussion on the follow up action of the last DDC meeting. Sector wise discussion of developmental sectors follows:

- 1. Irrigation:** The DC stated that public complaints have been received specially from Disangpani G.P that the installed Irrigation pumps are not functioning. The Ex. Eng. Irrigation was asked to verify the schemes and repair schemes within one week and submit action taken report before next DDC meeting. The AEE Irrigation informed that the issue of voltage problem in irrigation projects had been solved. The AEE Irrigation informed that out of 200 pumps under PMKSY, installation of 155 pumps (Solar and Electrical) had been completed. The DC directed to gear up the progress of installation and complete the work expeditiously. The Ex.Eng. Irrigation was asked to take prompt action for installation of irrigation projects in 176 small Tea gardens (Mahmora -149 Nos & Sonari- 27 Nos) under Small Tea Growers Association.
- 2. Agriculture:** The DC asked the DAO to take initiative for submission of data of commercial based farmers/ progressive farmers etc. for the purpose within 24<sup>th</sup> September/2021 under "Atma Nibharshil Assam" as sought by CMO office. Simultaneously, the DVO and DFDO were also asked to submit data for "Atma Nibharshil Assam" based on the instruction given to the DAO. With regards to PM KISHAN schemes, the Sr.ADO, Charaideo stated that verification for 27491 beneficiaries has been going on through Circle Officers and after receipt of final verification report from Circle Officers as well as from concerned bank branches, untraced PM KISHAN beneficiary would be uploaded in PM KISHAN portal before 25<sup>th</sup> September/2021. The DC directed the DAO to take all necessary arrangement for displaying the untraced PM KISHAN beneficiary in the notice boards of DC Office, DAO Office, Rev. Circle Offices, BDO's Office, Gaon Panchayat Offices etc. where public may access the untraceable name list and those who are in the list they may claim/verify themselves before the concerned notified officials within 21 days starting from 25<sup>th</sup> September/2021. If the untraced PM KISHAN beneficiaries fail to prove their claim within the prescribed time limit, they would be marked as Ineligible for PM KISHAN scheme.
- 3. PWD (Building):** The EE, PWD (B) informed that the construction of DTO office has been going on and 10% work has been done till date. He informed that for construction of Classroom and Science laboratory of Bhoju HE School, land has been handed over by the H.M. of the School. The EE, PWD (B) stated that Plan & Estimate of kitchen in District Jail had already been submitted. He stated that the construction of BOP at Kanubari would be completed by Oct/2021. Archery Academy playground work has not started because of water logging. He also informed that revised Estimate has been prepared for electrification in Sapekhathi VSC. He appraised that after depositing due payment, electric connection in the VSC would be done. The DC asked the EE, PWD (B) to submit plan & estimate of Facilitation Centre cum Common Workshop building for public in the vicinity of DC's office, Charaideo by 27<sup>th</sup>sept/2021.

**PWD (Roads):** The EE, PWD (R) stated that one approach road of a bridge taken up during 2016-17 has been started and six bridge approach roads of 2017-18 would be completed by October/2021. He also informed that all the schemes would be completed by Dec/2021 as per the direction of government. The EE, PWD (R) informed that sanction for 16 new schemes have been received under PMGSY. He mentioned that out of 289.35 km roads and 17 bridges taken up under PMGSY, 272.66 km roads and 11 bridges have been completed. The meeting also discussed the progress of the roads and bridges taken up under SOPD (G) -234 nos. , SOPD (ODS) -105 nos, Asom mala, CM's Special Package, Signature Project, Assam Darshan etc. The DC asked the Ex. Eng. PWD(R) to complete the Land acquisition process of Asom Mala project immediately. The DC also suggested to take necessary action to renovate the traffic point at Bhoju Chariali immediately and install a "Welcome" signboard at the entry point to the district in NH-52-B. *Dhruvhar Ali. at Garumuz.*

- 5. Water Resources:** The EE, Sivasagar, W.R. stated that the department had already submitted eight proposals to District Disaster Management Authority and it is expected to receive approval shortly. He stated that restoration works could not be started due to rainy season; however, works would be started in the month of Oct/2021.
- 6. Fishery:** The DFDO stated that the supply of "Fish seedling" has completed. He informed that Govt. has launched a new project to "Develop 10000 hector of village community tanks" in the state. It is for implementation in every revenue village of the state for enhancing fish production. He further appraised that NABARD has launched a new project viz. Rural Infrastructure Assistance to State (RIAS) to provide financial assistance for creating Rural Livelihood Infrastructure between NABARD & State on 95:5 basis. The tank will be constructed on Khas land or suitable land with minimum size of pond 1 hector. For this purpose, he requested the DC to allot suitable land for excavation of pond. The DC directed him to survey suitable land for the purpose and meets the concerned COs in this regard. The COs of Sonari/Sapekhati/Mahmora also asked to identify suitable plot of land for fishery scheme. The DC advised that while implementing fishery schemes, priority should be given for engagement of local people.
- 7. Education:** The DC asked the Inspector of Schools to liaise with the Principal/ HM for expedite submission of UC's of const. of school play ground under Sports department. The IS informed that he would discuss with the concern school about the matter. He stated that the fund of Rs.10.00 lakh sanctioned for construction of Science Lab in Mahmora Balijan School has been utilized and the UC would be submitted soon.
- 8. Veterinary:** For establishment of pound system in the district, DC directed the DVO to discuss with the CEO, ZillaParishad urgently.
- 9. District Elementary Education:** Regarding amalgamation and rationalization of teachers, the DC directed the DEEO to update the teachers' data and keep ready for implementation of Govt. decision as and when received from Govt.
- 10. SSA:** The Mission Coordinator, SSA, informed that the physical progress of construction of Girls toilet at Chuladhara LP School is 75%, Progress of Repair & renovation work of Kanu ME School and Kasturba Gandhi Balika Vidyalaya is 80%. The DC directed the Coordinator to supervise work regularly and complete the projects expeditiously.
